<u>ASSISTANT PRINCIPAL'S REPORT</u> – Asst. Principal Wolfe stated that the attendance report for August was 94.19%. He reported that he had 29 contacts with 27 students. Out of those, 18 were general conference with 16 students. Disciplinary consequences given to students were: 1 lunch detention for 1 student; 3 Crisis Classes for 3 students; 3 Saturday Schools for 3 students; and 4 out of school suspension for 4 students. He reported that the requirement for grade school students to have an adult with them at football games made it much better.

<u>PRINCIPAL'S REPORT</u> – Principal Boles reported that our enrollment at midterm is: 165 Freshmen, 181 Sophomores, 177 Juniors, 193 Seniors for a total of 716. He stated that last Friday was an 11:30 dismissal. Required emergency drills were done that morning. The 2nd half of the day was mandated trainings for staff.

Principal Boles reported that Homecoming will be the week of October 2, with the Homecoming football game on October 6 and the Homecoming dance will be October 7.

Principal Boles reported that the Marching Wildcats received best in flag, best in percussion, best Drum Major, and an overall first place in their class at the Robinson competition. Congratulations to Mr. Randolph and the Marching Wildcats. He reported the boys' golf regionals will be on Wednesday at Greenview in Centralia and girls' golf regional will be on Thursday in Effingham. The Lady Wildcats volleyball team is hosting their Pink Out Game on October 10. Staff is donating \$20 to be able to wear jeans for the month of October. They have chosen Harvey & Faith Evans to receive the proceeds from the Pint Out Game.

<u>SUPERINTENDENT'S REPORT</u> – <u>SHRINER'S HOSPITAL DONATION</u> – Supt. Detering recommended donating 40% of the gate from the Shriner's Football Game to the Shriner's Hospital. He stated this percentage has been the donation that goes back to when Barb Smith reinstituted it. The amount is \$2,548. He stated that we had a good turnout for the game and the field was in great shape thanks to maintenance and custodial staff Tom Thomason, Tracy Richie, Doug Telford and Tony Dial. <u>RURAL SCHOOLS</u> – Supt. Detering reported that, in an effort to continue learning and serving the District, he applied to and was selected for the "Reimagining Rural Education Cohort."
